# Certemy Updates and FAQ



When logging into Certemy for license renewal this spring you will notice the forms have been updated. The office staff and Certemy have been working with Certified Public Accountants (CPAs) to streamline the forms and clarify the renewal process. The goal moving forward is to be able to upload certificates as they are earned throughout the year rather than uploading several certificates in one sitting. Certemy is also working on a simple report that summarizes the CPE information provided. Once the report is complete you should be able to log into your account to monitor the CPE upload and keep track of the credits reported. Certemy will start collecting that data with the 2022-23 reporting period and will have the full three year look back after the 2024-25 reporting period. Going forward you will be able to look up your rolling three-year total 24/7.

In the meantime, here are some quick Certemy tips.

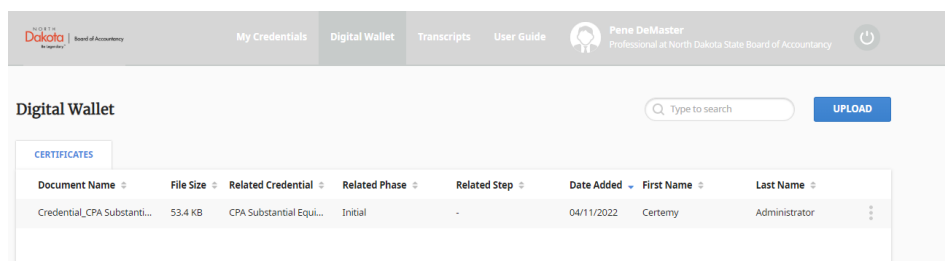
## Certemy FAQ

Q: Why didn't I receive my receipt for payment?

A: The North Dakota State Board of Accountancy no longer mails paper or emails digital receipts. To retrieve your receipt log into Certmy and click on Digital Wallet along the top middle of the screen. Click on the receipts tab. Follow the receipt line to the right side of the screen and click on the three dots stacked on top of each other. Choose to download the file and save to the desktop of your computer. You can print it from there.

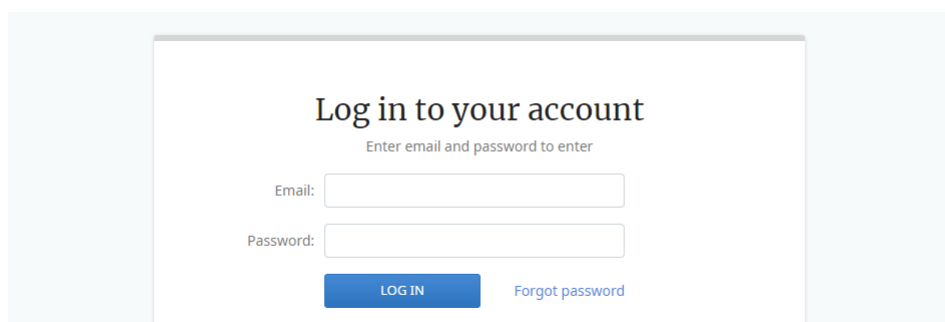
Q: Why didn't I receive my license card or firm permit?

A: To retrieve your license card or firm permit log into Certmy and click on Digital Wallet along the top middle of the screen. Click on the certificates tab. Follow the certificate line to the right side of the screen and click on the three dots stacked on top of each other. Choose to download the file and save to the desktop of your computer. You can print it from there.



Q: How do I change my password?

A: To change your password, go to the log in page <https://ndsba.certemy.com/entry/login>. Click on the "forgot password" button. Certemy will send a link to the email address on file for your account to reset your password.



Q: How do I change my contact details?

A: Log into your Certemy account. Hover over the picture next to your name at the top of the screen. A blue Profile details link will appear, click on the blue link. Your details menu will pop up on the left side of the screen. Click any of the blue links to choose which information you would like to edit. Then click in the individual field to update your contact information.

Q: Why does my renewal say CPA Exam Licensure or CPA Substantial Equivalency?

A: No need to worry, you do not need to sit for the exam again. This is how Certemy labels the type of license you have. If it reads CPA Exam Licensure that means you sat for the exam through North Dakota. If it reads CPA Substantial Equivalency that means that you transferred your license from another state.

Q: Why does my renewal say incomplete?

A: To check the due date of your renewal click on the credential. The due date is listed under each step.

The North Dakota State Board of Accountancy office is working with Certemy to provide some tutorials on the renewal process and uploading your CPE in Certemy. Those will be posted on the North Dakota State Board of Accountancy website once they are complete.

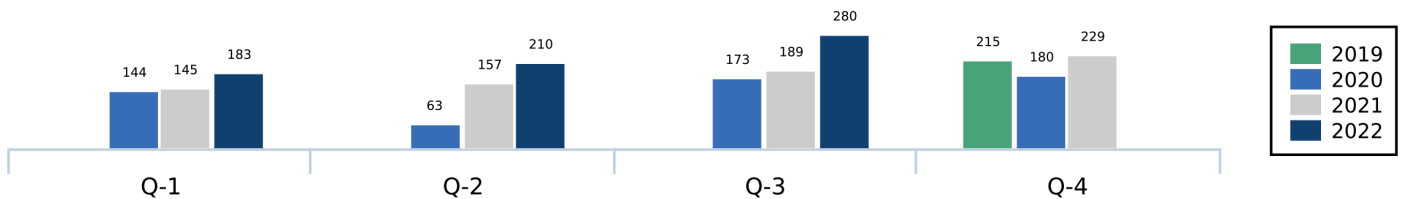

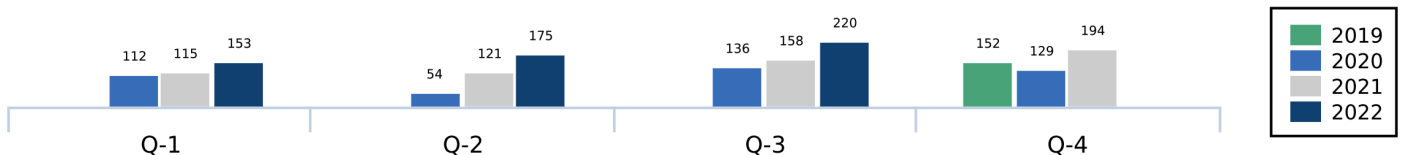

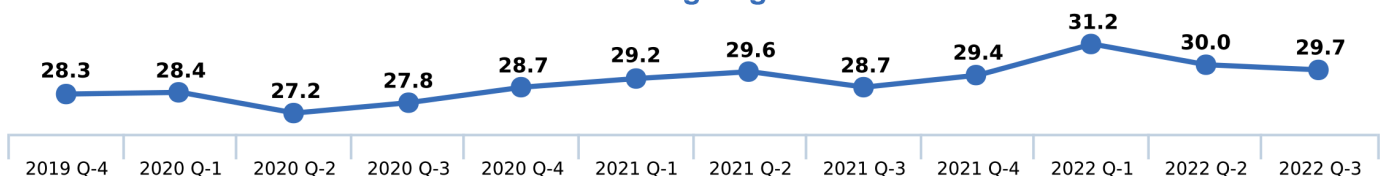
