
or better on the AICPA Uniform CPA exam and who passed all four parts on the first try. Barandi was one of the 137 in 75,000 eligible for the award.

Continuous Testing

Beginning July 1, 2020 testing windows and blackout dates are a thing of the past. NASBA rolled out continuous testing early in response to the COVID pandemic but was planning on the roll out for some time. They say they will not go back to testing windows or blackout dates. NASBA would only plan blackout dates for implementing new updated exams.

Continuous testing gives candidates the advantage of being able to take the exam year-round without restriction. Although candidates will have to wait for previous scores before re-taking an exam in the same section.

As a result, scores are now released on a rolling basis. Candidates will be able to receive their scores timelier. The Target score Release Timeline can be found on the AICPA website at https://www.aicpa.org/becomeacpa/cpaexam/psychometricsand-scoring/test-windows-score-release.html.
